IMPORTANT INFORMATION

1. Limitations are as follows: Skate Rental is not included at Ice Palace. It is not valid for either Skyflyer Zipline or Flowrider in World Waterpark. It is not valid at Senior's Skate or any other special event or private function. Ed's Alien Escape Room is not included. Drive is not included.
2. Payment must be made by Visa, Mastercard, or Discover card only (with a card whose expiry is valid throughout the whole payment time frame).
3. The wristband must be scanned at each attraction for admission.
4. If your wristband is lost or stolen, call 780-444-5321 immediately. A fee of \$10 plus GST will be charged to replace a lost, forgotten or stolen wristband. Proof of identification will be required. There are no exceptions or refunds. A cardholder who has not lost their card, yet wishes to gain admittance without one will be required to buy a replacement card in order to receive access to the attractions.
5. Children two years and under attend parks and attractions for free, excluding Ed's Bowling.
6. At all parks and attractions, children six years and under **MUST** be accompanied by a chaperone 18 years or older. Children aged seven to ten **MUST** be accompanied by a chaperone 16 years or older, and children 11 years and older do not require a chaperone, with the exception of Sea Life Caverns and Sea Lions' Rock, which require a minimum age of twelve. A paid admission fee for the chaperone may be applicable.
7. There is **NO** outside food or drink permitted in World Waterpark or Ed's Bowling.

TERMS AND CONDITIONS

1. Anyone who falsifies, forges, counterfeits, alters or tampers with the Pass will be prosecuted.
2. All passholders are subject to the rules, regulations and safety codes of West Edmonton Mall parks and attractions, such as height and age restrictions. These terms are subject to change without notice. Passholders are subject to admissions at all parks and attractions on a first-come, first-served basis.
3. West Edmonton Mall reserves the right to terminate any Pass and privileges associated with it at any time, with or without cause; exclude a passholder from promotional offers directed to the general public; and request additional information from a passholder. Pass is subject to availability when booking during existing social climate and government regulations on capacity limits of the attraction.
4. The Pass is property of West Edmonton Mall. It is non-transferable, non-refundable and may not be resold.
5. The Pass may not be used in any promotional manner without prior written consent of West Edmonton Mall Property Inc.
6. All parks and attractions in West Edmonton Mall including, without limitation, Galaxyland Amusement Park, World Waterpark (including SkyFlyer Zipline and FlowRider), Marine Life (including Sea Life Caverns, Sea Lions' Rock Show and Sea Lion Encounter), Deep Sea Adventure Lake (including The Ship), Ed's Bowling (including Alien Outbreak Escape Room), Ice Palace, Professor Wem's Adventure Golf, Dragon's Tale Blacklight Mini Golf (Including Crystal Labyrinth Mirror Maze), and Drive Go-Karts (collectively, the "Attractions") are operated by West Edmonton Mall Property Inc. ("WEM"), its affiliates and those for whom WEM is legally responsible, including but not limited to, its directors, officers, employees, contractors, and agents (collectively, the "WEM Releasees"). I hereby acknowledge that use of the Attractions may involve risks and dangers of serious injury, including permanent disability, paralysis and death; that these risks may be caused by my own actions or inactions, the actions or inactions of other participants, or the negligence of the WEM Releasees; and that I fully accept and assume all such risk and responsibility for losses, costs and damages which I may incur as a result of my participation in the Attractions and confirm that the WEM Releasees shall not be liable for any injury, loss, or damage whatsoever suffered by me, in, on, using, or in connection with the Attractions or any activities incidental thereto.
